





Tom, as a boy lived in Nampo, at 58 years in order to meet the Aus-Shanghai, Tokyo, Seoul until WW2 ended in 1945 when his family was repatriated from Seoul to Japan and started new life from ashes. He was thirteen years of age.

Fortunately, he was able to resume education after a years break progressing to university and a Bachelor's Degree in International Eco-

nomics in 1957. He specialized in economic development of emerging economies.

At university his essays won two first prizes. This experience motivated Tom to write several essays about Australia after he migrated to this county.

Tom joined Mitsubishi Cor**poration** (Probably Japan's largest international trading company) and started his career exporting Japanese

textile fabrics dyed or printed to Oce- companies wishing to do business in ania, South America, and Middle East.





Hector was born in 1929 in Mosman. He was the first of two children to young parents who were both then at Teachers College. Hector's father's first post was to a small school at Dunedoo at the beginning of the Great Depression.

Although his father was in secure employment, Hector was aware of the surrounding circumstances of those days and of the frugality they imposed and of the charitable

acts of his mother to the less well off. They had a profound impact on Hector.

He also learned to value knowledge and academic achievement. He had a good singing voice winning prizes at Eisteddfods.

Hector and younger brother Malcolm both attended Mudgee High and then progressed to Sydney University where Hector studied Forestry, later going to the School of Forestry at Yarralumla from 1947 -52.

In 1954 Hector met Marjorie (Midge), a botanist at the Forestry Commissions Department of Wood Technology in Sydney. They shared a curiosity and interest in the natural environment and spent their first three years in Newcastle while Hector was engaged on fieldwork in the Barrington Tops.

Those of us who were fortunate enough to go on the Probus trip organised by Bruce Simpson, John Herron and John Cowlishaw to Gloucester in 2008 will surely remember the day on the Barrington Tops. I recall that this was greatly informed by Hector who gave us first hand recollections of his involvement as Forrester. Between 1964 and 1970 Hector took leave from the Forestry Commission and went, with family, to work for the United Nations Development Programme in South Korea.

He returned to the Forestry Commission and was made District Forrester in the Forbes Office where he worked until 1977 when he returned to Head Office in Sydney. Hector was an ambitious handyman undertaking building work on their home in Killara. I am told he took enormous pride in doing everything himself feeling he was capable of doing a better job. This included design, kitchen construction, tiling, window installation and painting and, being a perfectionist, I am told some jobs took quite a long time.

Hector had been a smoker all his adult life indulging in cigarettes, a pipe and cigars and when I first joined Killara Bowling Club, as an ex-smoker, it was a fleeting pleasure to get the occasional waft of smoke from Hectors small cigars. However in 1987, at 58 years, Hector had to have a triple by-pass operation and there was permanent damage to heart and lungs.

Hector was Honorary Secretary of Killara Bowling Club for nine years and one task, a chore for Hector, was the preparation of the minutes of the monthly Committee meetings. This involved typing on an old (non-electric) typewriter in the Club Office; it was a chore he hated. I assume he did not have a word processor. Anyway in January 2002 he persuaded me to become Assistant Secretary and to take over the minutes.


Hector was a stylish and competent bowler and his name is on the honour boards around us. I feel very privileged to have known him. *John Muirhead.*



In 1997, now Archbishop, Grapje was serving in Zimbabwe when an explosion in a silver mine caused a cave-in. He went down into the mine to administer last rites to those too severely injured to move. Another shaft collapsed, and he was buried for three days, suffering multiple injuries, including the loss of his riaht eve.

The high silver content in the mine's air gave him purpura, a life-long condition characterized by purplish skin blotches.

Although Cardinal Grapje devoted his life to the service of God as a scholar, mentor, and holy man, church leaders felt that he should never ascend to the Papacy. They felt that the Church would never accept a one-eyed, one-armed, flying purple Papal leader.

Ever walk into a room and forget what that purpose was?


It turns out doors themselves are to blame for these strange memory lapses.


